Election Offenses/ Prohibitions/ Don'ts Based on Timelines

1. Starting **January 12, 2025** (Election Period | 120 days)
2. Starting **February 11** and **March 28, 2025** (Campaign Periods | 90 and 45 days)
3. Starting **March 13, 2025** (60 days before Election Day)
4. Starting **March 28, 2025** (45 days before Election Day)
5. On **May 11, 2025** (1 day before Election Day)
6. On **May 12, 2025** (Election Day)
7. Anytime

Firearms and Deadly Weapons

Governing Law	Section 32, RA No. 7166 and COMELEC Resolution No. 11067
Covered	Any person (even those with Permit to Carry Firearm outside of Residence, Letter Order and Mission Order)
Covered Period	Election Period (January 12 to June 11, 2025)
Prohibited Acts	Bear, carry or transport firearms or other deadly weapons in public places , including any building, street, park, private vehicle or public conveyance
Ban Exemption	Can carry, bear or transport if with written COMELEC authority (Certificate of Authority/ CA)
Grantor of Exemption	Committee on the Ban on Firearms and Security Concerns (COMELEC, PNP and AFP) or COMELEC Chairman
CA Types	Full Exemption Law Enforcement Agencies Diplomatic Missions Security Agencies Cashiers/ Disbursing Officers High-Risk Individuals Security Details Transport Sports Shooters Theatrical Property Shooting Range
Application	Applications must be exclusively submitted through electronic means via the official COMELEC website from Mondays to Fridays (excluding Saturdays, Sundays and Holidays) from 8:00 a.m. to 5:00 p.m.

ELECTION OFFENSE SERIES NO. 11

13 ACTS: VOTE-BUYING IS PRESUMED WHEN...

Section 26, COMELEC Resolution No. 11104

With possession of campaign materials and other corroborative evidence:



01 Possessing or delivering monies, pay envelopes, bags, groceries or anything of value with sample ballots or other campaign materials.



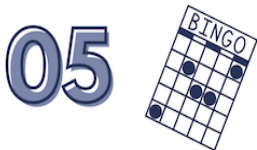
02 Offering or promising something of value for campaign purposes.



03 There are long lines/ queues for distribution of money, insurance/ health cards, grocery items for campaign purposes.



04 Giving money and grocery items during house-to-house campaigns.



05 Holding bingo games or talent shows with prizes where names of candidates are mentioned/ displayed.



06 Employing "hakot" system on May 11 and 12 for distribution of money and sample filled-out ballots.



07 Possessing or transporting P500,000.



08 Causing the splitting of P20,000 to smaller denominations.



09 Conducting medical missions, legal aid services and feeding programs where names of candidates are mentioned/ displayed.



10 Giving or distributing "ayuda" where names of candidates are mentioned/ displayed or "ayuda" which is not normally given to qualified individuals.



11 Hiring or appointing 2 pollwatchers per precinct per candidate.



12 Possessing indelible ink on May 12.



13 Possessing blank original ballots on May 12.

THESE ARE REBUTTABLE PRESUMPTIONS.

Release of Public Funds



Governing Law	Section 261 (v), Batas Pambansa Blg. 881 and COMELEC Resolution No. 11060
Liabe Persons	<ul style="list-style-type: none">○ For release of public funds: Any public official or employee○ For distribution of relief goods to the victims of the calamity or disaster: Candidate or spouse or member of family within the 2nd civil degree of affinity or consanguinity
Covered Period	Starting March 28, 2025 (45 days before regular elections)
Prohibited Activities	<ul style="list-style-type: none">○ Releases, disburses or expends any public funds for Public Works, Social Services (DSWD or LGU) and Housing-related Projects○ Distribution of relief or other goods to victims of the calamity or disaster
Excluded from Prohibition	<ul style="list-style-type: none">○ COMELEC exemption required: For Social Services and Housing-Related Projects, Assistance to Individuals in Crisis Situation○ COMELEC exemption not required: For Calamities and Disasters (but must report to COMELEC Law Department), Salaries and MOOE, and non-Social Services and non-Housing-Related activities established before March 28 and reported to COA provided not used for campaign
Procedure for Applying for Exemption	Use prescribed form Original Copy file with COMELEC Law Department Deadline to apply is February 11 Application may be opposed (summary hearing conducted) COMELEC Chairman to approve or disapprove recommendation

Raising of Campaign Funds

Governing Law	Section 97, Batas Pambansa Blg. 881
Covered	Any person (aspirant, candidate, political party, party-list organization, public officer, private individual and voter)
Period	Election Period (Interpreted as Campaign Period : Starting February 11 for national-elected and March 28 for locally-elected)
Prohibited Activities	Hold dances, lotteries, cockfights, games, boxing bouts, bingo, beauty contests, entertainments, or cinematographic, theatrical or other performances
Purpose of Activities	To be an Election Offense, the purpose of the activity must be to raise funds for an election campaign or for the support of any candidate

Giving Donations



Governing Law	Section 104, Batas Pambansa Blg. 881
Liable Persons	<ul style="list-style-type: none">○ Candidate, his/her spouse or any relative within the second civil degree of consanguinity or affinity, his/her campaign manager, agent or representative○ Treasurers, agents or representatives of any political party
Covered Period	<ul style="list-style-type: none">○ Campaign Period: Starting February 11, 2025 for nationally-elected officials and March 28, 2025 for locally-elected officials○ On the day before and on the day of the election (May 11 and 12, 2025)
Prohibited Activities	<ul style="list-style-type: none">○ Make any donation, contribution or gift in cash or in kind○ Undertake or contribute to the construction or repair of roads, bridges, school buses, puericulture centers, medical clinics and hospitals, churches or chapels cement pavements, or any structure for public use or for the use of any religious or civic organization
Excluded from Prohibition	<ul style="list-style-type: none">○ Normal and customary religious dues or contributions, such as religious stipends, tithes or collections on Sundays or other designated collection days○ Periodic payments for legitimate scholarships established and school contributions habitually made before the prohibited period

Free Transportation, Food and Drinks

Covered Period	<ul style="list-style-type: none"> ○ 5 hours before and after a public meeting/ rally held during the Campaign Period (<i>Starting February 11, 2025 for nationally-elected officials and March 28, 2025 for locally-elected officials</i>) ○ On the day before and on the day of the election (May 11 and 12, 2025)
Prohibited Activities	<ul style="list-style-type: none"> ○ Give or accept, free of charge, directly or indirectly, transportation, food or drinks or things of value ○ Give or contribute, directly or indirectly, money or things of value for such purpose.
